Hi Lucy, hi Mark,

Hope you are both well. I'll keep this short — forwarded me the below about her plan for LTNs. I sent this around to my residents, many of whom have come back to me with their views.

Broadly, we support enforcement of speed limits, perhaps a camera, width and weight restrictions on through traffic, enforcement of the TRO on Cavendish Road and other minimally-intrustive measures to safeguard walkers and cyclists in our lovely area of Bath. Much of Lansdown is residential, and those who travel through it must do so at a safe speed and, as much as possible, in vehicles that are appropriately sized for residential roads.

We are not in favour of modal filters that would alter the flow of traffic and prevent non-residents from using our roads. Some residents are concerned about diverting traffic elsewhere where it will cause congestion or further amplify pollution. Others are concerned that modal filters do not seem equitable, creating a "gated community" feel in our part of town.

I will add that, though we are not in favour of modal filters in our part of town, we are also concerned that other wards may propose schemes that would divert traffic our way. This is not acceptable or fair.

I realise that as a council you have decided in favour of LTNs, but I remain sceptical that closing roads will produce anything other than bad feeling, congestion and further problems. I feel it is important to state this and I would appreciate if you could make our views known as you discuss this project with the wider council group.

I am writing on behalf of Cavendish Crescent Association, Cavendish Road Society, St James's Square Bath Ltd and Lansdown Crescent Association (supported by Winifred's Lane residents and Sion Hill Place Residents)

Please find attached two documents. We would like the content of these to be used when you complete the proforma or to be submitted alongside the proforma to Highways Team.

These two documents have been prepared in collaboration with the Resident Groups mentioned above.

The first document is a word document summarising the problem, providing evidence of the problem, and providing a summary of possible interventions the different groups have discussed, finally addressing the level of support we do have and the level of objection from the adjacent RA which lives away from the affected roads but uses them.
